Hello Linda Johnson,

I got your information from Theresa Cohagen and Sgt. Ken Hopkins. They have helped me get this permit finalized so it can be approved as easily as possible.

I am with Life Time Fitness in Mansfield. We are looking to have a 5K fun run on January 1, 2015 called Commitment Day 2015. It's a chance for the city of Mansfield to dedicate the new year to living a healthy lifestyle and doing it together as a family, group of friends, or even individually. Run, walk, jog their first day of the year to set in motion a healthy way of life.

We will start and finish the event at Life Time Fitness on Debbie Lane. The race route travels south on Matlock, then turns east on Country Club to Mansfield Bible Church, U-turns in their parking lot, then return on the same route. Sgt. 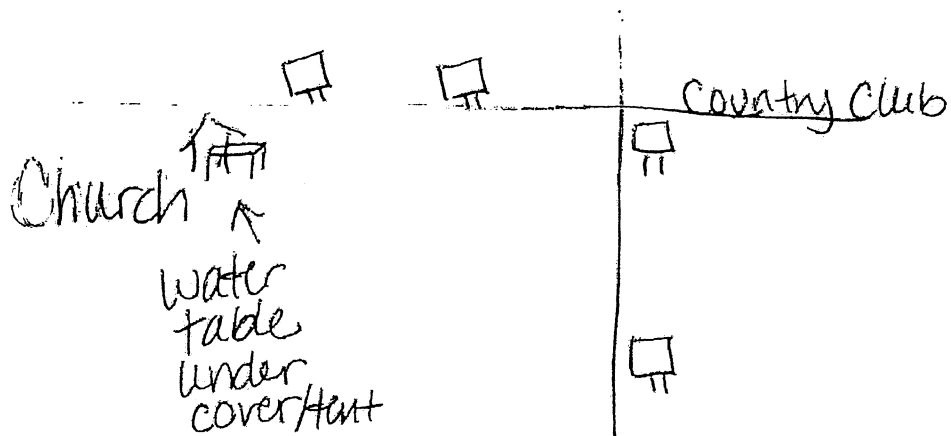
