Intercon Environmental, Inc. is pleased to submit our proposal for the asbestos abatement and demolition of the above referenced property.

Asbestos Abatement Scope of Work:

- Removal of approximately 2,900 square feet of asbestos containing popcorn ceiling texture.
- Removal of approximately 640 square feet of asbestos containing exterior texture on CMU.
- Estimated Project Duration for Asbestos Abatement is Four (4) Working Days.

Asbestos Abatement Price (per the noted scope of work)\$11,680.00

Demolition Scope of Work: Option #1 (Building Only, Foundation to Remain)

- Verify that utilities have been disconnected at the property line by others.
- Obtain demolition permits from City of Mansfield.
- Install temporary construction fence around perimeter of site.
- Removal and disposal of structure (building foundation to remain).
- Removal and disposal of designated fences.
- Estimated Project Duration for Demolition is Three (3) Working Days.

- Verify that utilities have been disconnected at the property line by others.
- Obtain demolition permits from City of Mansfield.
- Install temporary construction fence around perimeter of site.
- Removal and disposal of structure and foundation.
- Removal and disposal of sidewalk on north side of building.
- Removal and disposal of fences.
- Rough grade lot with existing soil to prevent ponding of water.
- Install silt fence as necessary for erosion control.
- Estimated Project Duration for Demolition is Two (2) Working Days.

Demolition Price (per the noted scope of work)......\$16,164.00

Demolition Scope of Work: Add Alternate

Removal and disposal of additional fencing.

Demolition Price (per additional linear feet of fence)\$3.00
