A RESOLUTION AWARDING CONTRACTS FOR THE CONSTRUCTION OF MATLOCK ROAD LEFT TURN LANE IMPROVEMENTS INCLUDING CAPKO CONCRETE STRUCTURES, LLC. FOR CONSTRUCTION, BRITTAIN AND CRAWFORD, LLC FOR SURVEYING, AND RABA KISTNER, INC. FOR MATERIAL TESTING AND AUTHORIZING FUNDING FOR AN AMOUNT NOT TO EXCEED \$275,129.86; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE. (STREET BOND FUND)

WHEREAS, the City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,

WHEREAS, the City of Mansfield has publicly advertised and requested competitive bids for the construction of Matlock Road Left Turn Lane Improvements; and,

WHEREAS, all bids were received, opened and publicly read aloud on September 11, 2024; and,

WHEREAS, it is recognized that it is in the best interest of the citizens of the City of Mansfield that the construction provided for herein be started at the earliest possible date to ensure necessary service and delivery; and,

WHEREAS, after review of all bids received, City staff believes that the "lowest and best" bid is that of Capko Concrete Structures, LLC; and,

WHEREAS, funding for this contract is available from the Street Bond Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

SECTION 1.

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

SECTION 2.

A Construction Contract with Capko Concrete Structures, LLC in an amount not to exceed Two Hundred Forty Seven Thousand Seven Hundred Twenty-Nine and 13/100 dollars (\$247,729.13) for the construction of the Matlock Road Left Turn Lane Improvements is hereby approved.

SECTION 3.

A Professional Services Contract with Brittain & Crawford, Inc. in an amount not to exceed Eleven Thousand and no/100 dollars (\$11,000.00) for the construction survey of Matlock Road Left Turn Lane Improvements is hereby approved.

SECTION 4.

A Professional Services Contract with Raba Kistner Associates, Inc. in an amount not to exceed Sixteen Thousand Four Hundred and 73/100 dollars (\$16,400.73) for material testing of Matlock Road Left Turn Lane Improvements is hereby approved.

SECTION 5.

This Resolution shall be effective from and after its passage.
