**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANSFIELD, TARRANT COUNTY, TEXAS, SUPPORTING THE TEXAS DEPARTMENT OF TRANSPORTATION AND THE NORTH TEXAS TOLLWAY AUTHORITY AND THEIR PLAN TO CONSTRUCT TOLLED MAINLANES AND CONTINUOUS FRONTAGE ROADS ON SH 360 FROM E. SUBLETT/W. CAMP WISDOM TO US 287; AUTHORIZING ITS EXECUTION BY THE CITY MANAGER OR DESIGNEE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Texas Department of Transportation and the North Texas Tollway Authority have planned improvements to the SH 360 corridor from E. Sublett/W. Camp Wisdom to US 287; and,

**WHEREAS**, rapid growth and development continues along the SH 360 corridor; and,

**WHEREAS**, the traffic volumes have increased as growth and development continues and significant travel delays occur daily along SH 360; and,

**WHEREAS**, the existing SH 360 Frontage road system is insufficient for current traffic demand; and,

**WHEREAS**, the addition of tolled main lanes to SH 360 will improve air quality, mobility and access for residents and businesses of the City of Mansfield, as well as surrounding areas;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TARRANT COUNTY, TEXAS, THAT:**

**SECTION 1.** The City of Mansfield supports the Texas Department of Transportation and the North Texas Tollway Authority's schematic design to construct SH 360 from E. Sublett/W. Camp Wisdom to US 287 as toll road with continuous frontage roads and to move forward with the construction project as soon as practical.

**SECTION 2.** The City Secretary shall forward a certified copy of this Resolution to the Texas Department of Transportation and the North Texas Tollway Authority.

**SECTION 3.** This Resolution shall take effect immediately from and after its passage.
