**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, SUPPORTING AN APPLICATION FROM THE CITY OF MANSFIELD, TEXAS TO THE UNITED STATES DEPARTMENT OF ENERGY FOR 2021 ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT PROGRAM FORMULA GRANT IN AN AMOUNT NOT TO EXCEED \$129,070.00 TO RETROFIT EXISTING PUBLIC BUILDINGS IN THE CITY OF MANSFIELD, TEXAS WITH ENERGY EFFICIENT LIGHTING; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE**

**WHEREAS**, the United States Department of Energy issued a formula grant for projects for energy efficiency through the Energy Efficiency and Conservation Block Grant Program for communities to apply for funding assistance for programs that prioritize reducing carbon emissions, improving energy efficiency, and reducing energy use; and,

**WHEREAS**, the City of Mansfield is eligible to submit an application to seek funding through the Energy Efficiency and Conservation Block Grant Program to retrofit existing public buildings within the City of Mansfield with energy efficient lighting; and,

**WHEREAS**, the formula grant allocated to the City of Mansfield for an amount not to exceed One Hundred Twenty-Nine Thousand Seventy and no / 100 dollars (\$129,070.00); and,

**WHEREAS**, the grant does not require a local match.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:**

**SECTION 1.**

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

**SECTION 2.**

The City Manager or his / her designee is authorized to execute all documents and to make an application to the United States Department of Transportation for the Energy Efficiency and Conservation Block Grant Program.

**SECTION 3.**

It is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law and the public notice of the time, place, and purpose of said meeting as given as required.

**SECTION 4.**

This Resolution shall be effective from and after its passage.
