We are located on Main Street, 2 miles south of downtown Mansfield, in-between Heritage and Lone Star Road (just west of highway 287).

Will the color ruin clothes or running shoes?

The color does mostly wash out after the event. As with anything dirty, the sooner you wash it the better. We suggest wearing items that you wouldn't mind getting colorful. If you would like to preserve the color in your running shirt, spray it with vinegar and iron it. If you wash your shirt....the color will eventually come out.

Do the "Color Zones" affect runner vision? Or breathing?

The color powder used at the event is all 100% non-toxic. Our bright colors are cornstarch and FD&C dyes. As with any substance, you want to keep it out of your eyes. Some runners opt to wear glasses or goggles for their eyes and use a bandana or dust mask for their mouths.

Do you have "cleaning stations" at the finish after party?

We have air blown color cleaning at the finish line. With a good dusting off, you aren't 100% clean, but you are good for the drive home. It is actually pretty fun to see people still colorful around town after the event. It is like a badge of honor!

How does the color affect the inside of cars?

Most people bring some towels for the insides of their cars just in case.

Can spectators attend the post-race festival?

Absolutely! We will have color packets available first come/first serve for everyone to purchase. You may want to warn them though... they may not come out of the festival clean!

Are cameras and phones safe to have in the color zones?

If you want to get shots right in the midst of the color we recommend covering cameras/phones with plastic wrap.

Is The Color Run timed?

The Color Run is not a timed event. Runners tend to take their sweet time out there and we realize no one really cares about their speed. However, at our post race awards ceremony, we will recognize the first few elementary age children who cross the finish line the quickest.

Are there refunds?

We cannot issue refunds. Just make sure you are good to go before signing up. If for some reason you can't make it race day, you can still pickup your race packet that day or the week after the race!

What if I am pregnant?

It's totally up to what you and your doctor decide. We see a lot of pregnant runners at our races and they are the cutest ones out there! The powder is all certified non-toxic. We recommend wearing sunglasses or goggles, and a bandana over your mouth and nose in the color zones just for extra protection.

What happens if there is bad weather?

A little rain won't stop the happiest Color Run! It even makes the color brighter! If there are major weather warnings during the weekend of the event, check the Annette Perry Elementary web page for event updates. http://perry.mansfieldisd.org/
