A RESOLUTION AWARDING CONTRACTS FOR THE CONSTRUCTION OF GERTIE BARRETT ROAD PAVING IMPROVEMENTS INCLUDING RELIABLE PAVING, INC. **WHEREAS**, the City of Mansfield has publicly advertised and requested competitive bids for the construction of Gertie Barrett Road Paving Improvements; and,

**WHEREAS**, all bids were received, opened and publicly read aloud on February 15, 2024; and,

**WHEREAS**, it is recognized that it is in the best interest of the citizens of the City of Mansfield that the construction provided for herein be started at the earliest possible date to ensure necessary service and delivery; and,

**WHEREAS**, after review of all bids received, City staff believes that the "lowest and best" bid is that of Reliable Paving, Inc.; and,

**WHEREAS**, funding for this contract is available from the Street Bond Fund and Utility Fund.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

## **SECTION 1.**

A Construction Contract with Reliable Paving, Inc. in an amount not to exceed One Million Six Hundred Three Thousand Eight Hundred Twenty-Eight and 96/100 dollars (\$1,603,828.96) for the construction of the Gertie Barrett Rd. Paving Improvements is hereby approved.
