A RESOLUTION OF THE CITY OF MANSFIELD, TEXAS, AUTHORIZING FUNDING IN AN AMOUNT NOT TO EXCEED \$490,500.00 AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO ENTER INTO INTERLOCAL AGREEMENTS WITH TARRANT COUNTY FOR THE ASPHALT RECONSTRUTION OF MEADOW CREEK DRIVE AND CHIMNEY HILL COURT; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE (2024 STREET BOND FUND)

- **WHEREAS**, The City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,
- **WHEREAS**, it is recognized that it is in the best interest of the citizens of the City of Mansfield to enter into Agreements with Tarrant County to reconstruct Meadow Creek Drive and Chimney Hill Court; and,
- **WHEREAS**, Tarrant County and the City of Mansfield are both governmental entities engaged in the purchase of goods and services, which is a recognized governmental function; and,
- **WHEREAS**, the Interlocal Act contained in Chapter 791 of the Texas Government Code provides legal authority for parties to enter into this agreement; and,
- **WHEREAS**, Tarrant County and the City of Mansfield have agreed to said terms of the Agreement; and,
- **WHEREAS**, the City of Mansfield and Tarrant County have agreed to contract with each other to reconstruct Meadow Creek Drive and Chimney Hill Court; and,
- **WHEREAS**, it is necessary to authorize and secure funds from the 2024 Street Bond Fund.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS:

## **SECTION 1.**

That the findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

## **SECTION 2.**

That the City Manager or designee is hereby authorized and directed to execute Interlocal Agreements with Tarrant County to reconstruct Meadow Creek Drive and Chimney Hill Court.
