IN AN AMOUNT NOT TO EXCEED \$1,155,000.00, AND BRITTAIN AND CRAWFORD, LLC IN AN AMOUNT NOT TO EXCEED \$71,500.00 FOR THE DESIGN AND SURVEY, RESPECTIVELY, OF EAST BROAD STREET (FIRE STATION TO HOLLAND RD.) (STREET BOND FUND)

**WHEREAS**, The City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,

**WHEREAS**, the City Council recognizes the need to proceed forward with design and survey for East Broad Street (Fire Station to Holland Rd.); and,

**WHEREAS**, Kimley-Horn and Associates, Inc. has provided a proposal for the design in an amount not to exceed One Million One Hundred Fifty-Five Thousand and no/100 dollars (\$1,155,000.00); and,

**WHEREAS**, after review of the proposal City staff recommends approving a professional services contract with Kimley-Horn and Associates, Inc.; and,

**WHEREAS**, Brittain and Crawford, LLC has provided a proposal for the survey in an amount not to exceed Seventy-One Thousand Five Hundred and no/100 dollars (\$71,500.00); and,

**WHEREAS**, after review of the proposal City staff recommends approving a professional services contract with Brittain and Crawford, LLC; and,

WHEREAS, funding for this contract is available from the Street Bond Fund.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

## **SECTION 1.**

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

## **SECTION 2.**

A Professional Services Contract with Kimley-Horn and Associates, Inc. in an amount not to exceed One Million One Hundred Fifty-Five Thousand and no/100 dollars (\$1,155,000.00) for the design of East Broad Street (Fire Station to Holland Road), in substantially the same form as the attached Exhibit "A", is hereby approved.
