A RESOLUTION OF THE CITY OF MANSFIELD AUTHORIZING THE CITY MANAGER AND THE POLICE DEPARTMENT TO RECEIVE AND EXPEND GRANT FUNDS FROM THE FY2015 HOMELAND SECURITY GRANT PROGRAM (HSGP) IN AN AMOUNT NOT TO EXCEED \$20,000 WITH NO LOCAL MATCH REQUIRED.

WHEREAS, The Mansfield Police Department is a local government law enforcement agency and meets the criteria established by the Homeland Security Grant Program to receive and expend grant funds under this program; and

WHEREAS, there is approximately \$20,000 available to the Mansfield Police Department from the State Homeland Security Program (SHSP) funded by the HSGP; and

WHEREAS, the City of Mansfield, and the Mansfield Police Department, agrees to comply with all program rules as set out in the grant program guidelines; and

WHEREAS, the City of Mansfield agrees that in the event of loss or misuse of the State Homeland Security Program funds, the City of Mansfield assures that the funds will be returned to the SHGP in full; and

WHEREAS, the City of Mansfield designates Clayton W. Chandler (City Manager) as the grantee's authorized official. The authorized official is given the power to accept, reject, alter, or terminate the grant on behalf of the agency; and

WHEREAS, the City Council desires to ratify and authorize the City Manager, and the Mansfield Police Department, to receive and expend the above mentioned grant allocation, if awarded.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

SECTION 1.

1. The City Manager or designee is authorized to execute all documents and receive and expend state and/or federal funds from the FY2015 State Homeland Security Program funded through the FY2015 Homeland Security Grant Program.

Subject: 2015 SHSP SWAT Tactical Robot Project and New Grant System

Good afternoon,

Earlier this year, the regional SWAT Working Group submitted a 2015 State Homeland Security Program (SHSP) project to purchase tactical robots for SWAT teams. The State fully funded the project at the recommended amount of \$80,000. This provides \$20,000 for four teams selected by the SWAT Working Group leadership: City of Cleburne, City of Mansfield, Parker County, and the City of Rockwall.

The State Administrative Agency (SAA) that administers the SHSP grant program is transitioning to the Office of the Governor and their eGrants system. The SAA was able to load the projects into eGrants, and I have worked on the few remaining sections the SAA needed us to fill in from the original project submissions.

What I need from you:

- Authorized Official
- Financial Officer
- Project Director
- Grant Writer—base position that only has viewing rights after projects are entered.

I am currently assigned as the grant writer to work on each project in eGrants. If you plan to have local staff in the Grant Writer position, we'll assign it after the rest of the project is ready to go so I don't lose visibility. Once the Officials are assigned in eGrants, I will follow up with the next steps to review, complete, and verify the grant project.

FY 2015 Homeland Security Grant Program

The Homeland Security Grant Program (HSGP) plays an important role in the implementation of the National Preparedness System by supporting the building, sustainment, and delivery of core capabilities essential to achieving the National Preparedness Goal (the Goal) of a secure and resilient Nation. The building, sustainment, and delivery of these core capabilities are not exclusive to any single level of government, organization, or community, but rather, require the combined effort of the whole community. The HSGP supports efforts to build and sustain core capabilities across the five mission areas of Prevention, Protection, Mitigation, Response, and Recovery based on allowable costs.

Fiscal Year 2015 Homeland Security Grant Program

HSGP is comprised of three interconnected grant programs:

- State Homeland Security Program (SHSP)
- Urban Areas Security Initiative (UASI)
- Operation Stonegarden (OPSG)

Together, these grant programs fund a range of preparedness activities, including planning, organization, equipment purchase, training, exercises, and management and administration.

Total Funding Available in Fiscal Year (FY) 2015: **\$402,000,000**

PURPOSE

The SHSP assists state, tribal and local preparedness activities that address high-priority preparedness gaps across all core capabilities and mission areas where a nexus to terrorism exists. SHSP supports the implementation of risk driven, capabilities-based approaches to address capability targets set in urban area, state, and regional Threat and Hazard Identification and Risk Assessments (THIRAs).
