

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF MANSFIELD, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF MANSFIELD BY AMENDING CHAPTER 71, SECTION 71-20, SECTION 71-23, AND SECTION 71-28 CODE OF ORDINANCES, CITY OF MANSFIELD, TEXAS; DESIGNATING CERTAIN STREETS AS TRUCK ROUTES OR COMMERCIAL DELIVERY ROUTES; TO PROVIDE A MAXIMUM SIZE OF CERTAIN TYPES OF MOTOR VEHICLES OPERATED ON PUBLIC STREETS WITHIN THE CITY; TO PROVIDE A MAXIMUM WEIGHT FOR CERTAIN VEHICLES OPERATED ON PUBLIC STREETS WITHIN THE CITY; TO PROVIDE PERMIT REQUIREMENTS FOR OVERSIZE AND OVERWEIGHT VEHICLES; PROVIDING A SEVERABILITY CLAUSE, PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO HUNDRED AND FIFTY DOLLARS (\$250.00) FOR EACH OFFENSE AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS:

SECTION 1.

That Section 71-20 of the Code of Ordinances of the City of Mansfield, Texas be,
and the same is hereby amended to read as follows:

“Sec. 71-20 Definitions

Designated City Official. Any City employee designated as such by the City Manager or his designee.

SECTION 2.

That Section 71-23 of the Code of Ordinances of the City of Mansfield, Texas be,
and the same is hereby, amended to read as follows:

“Sec. 71.23. Signs to Designate Truck Routes.

(a) The following streets and parts of streets are designated truck routes
under this article:

US 287 through the City

SH 360 through the City

FM 157 through the City

BU 287 through the City

FM 1187 from the West City Limits to BU 287

FM 917 / Heritage Parkway from the West City Limits to SH 360

(b) The following streets and parts of streets are designated commercial delivery routes under this article:

Debbie Lane from BU 287 to the East City Limits

Broad Street through the City

Walnut Creek Drive from East Broad Street to the North City Limits

Country Club Drive from Walnut Creek Drive to Matlock Road

Matlock Road from the North City Limits to East Broad Street

South Wisteria Street from Union Pacific Railroad to Heritage Parkway

Heritage Parkway from US 287 to SH 360

SECTION 3.

That Section 71-28 (d) of the Code of Ordinances of the City of Mansfield, Texas be, and the same is hereby, amended to read as follows:

“Sec 71.28. Permit Required for Oversize and Overweight Vehicles.

(d) A fee shall be charged for each permit as follows.

Single trip permits - \$10

Periods not exceeding 30 days - \$15

Periods not exceeding 60 days - \$20

Periods not exceeding 90 days - \$25

Periods not exceeding one year - \$50

SECTION 4.

That all ordinances of the City in conflict with the provisions of this ordinance be, and the same are hereby, repealed and all other ordinances of the City not in conflict with the provisions of the ordinance shall remain in full force and effect.

SECTION 5

Should any paragraph, sentence, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof, other than the part so declared to be invalid, illegal or unconstitutional, and shall not affect the validity of the Code of Ordinances as a whole.

SECTION 6

Any person, firm, or corporation violating any of the provisions of this ordinance or the Code of Ordinances, as amended hereby, shall be deemed guilty of a misdemeanor and, upon the conviction in the Municipal Court of the City of Mansfield, Texas, shall be

punished by a fine not to exceed the sum of Two Hundred and Fifty Dollars (\$250.00) for each offense, and each and every day any such violation shall continue shall be deemed to constitute a separate offense.

SECTION 7.

This Ordinance shall be effective from and after its adoption and publication as required by law.
