

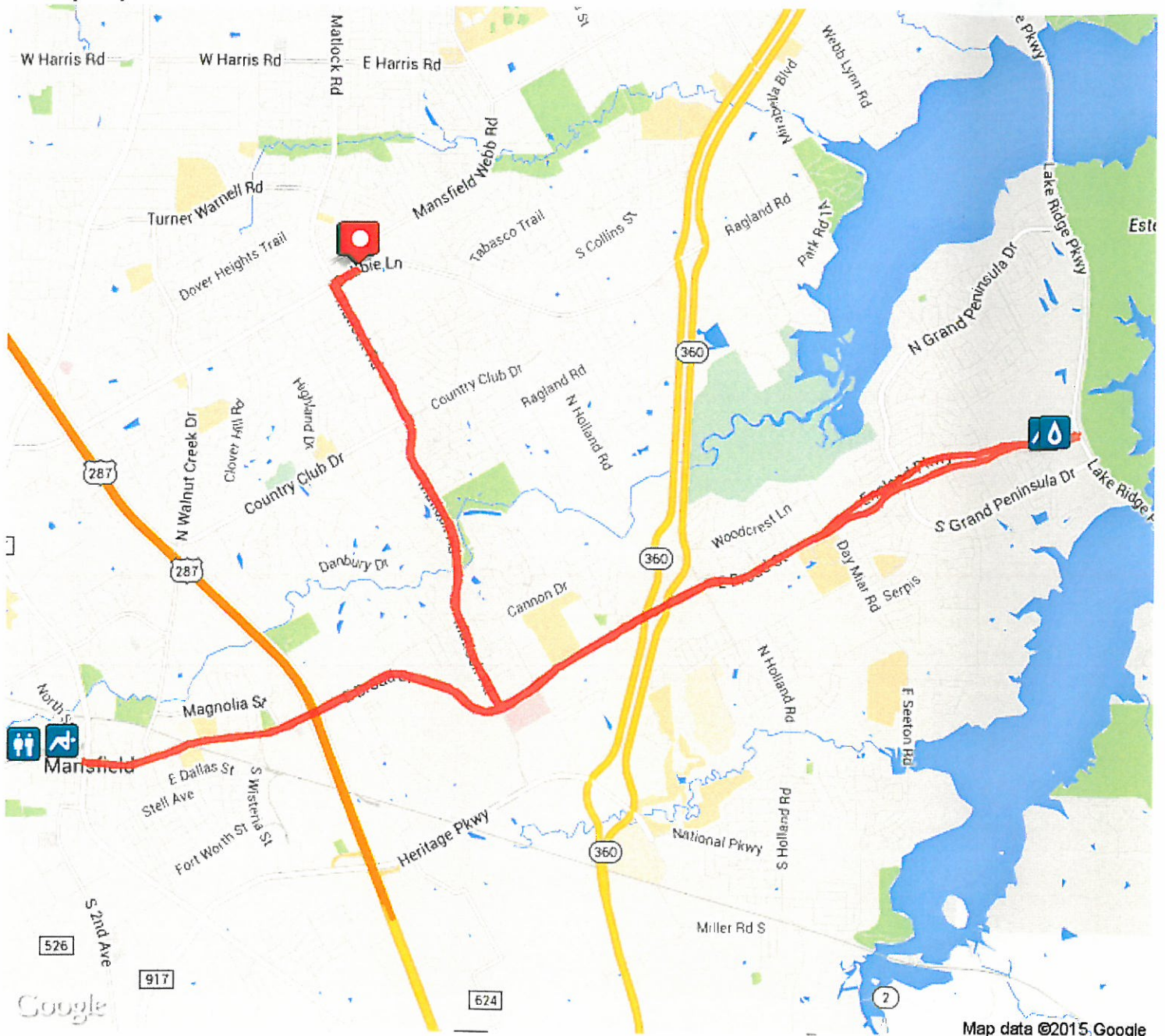


Bike Out Hunger Mansfield 20mi 2015

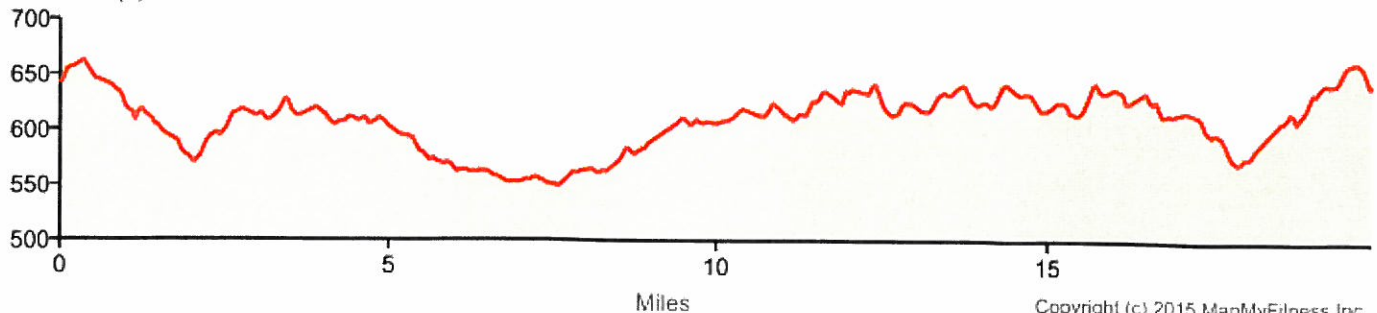

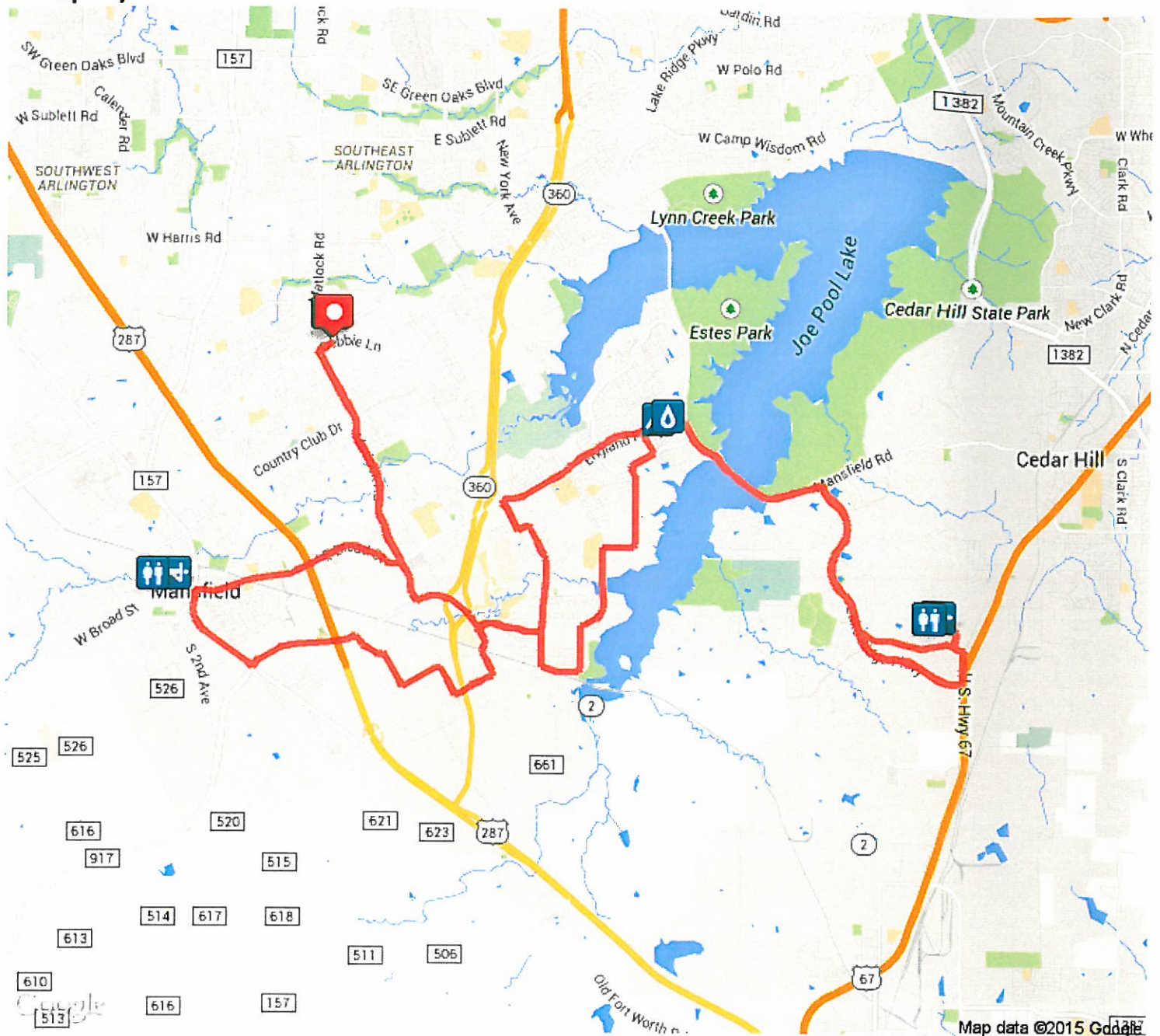


Bike Out Hunger Mansfield 42mi 2015

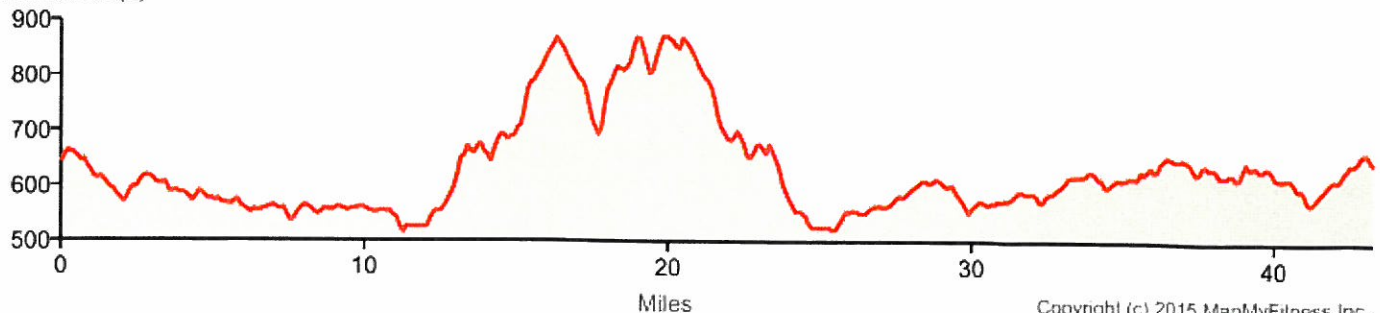

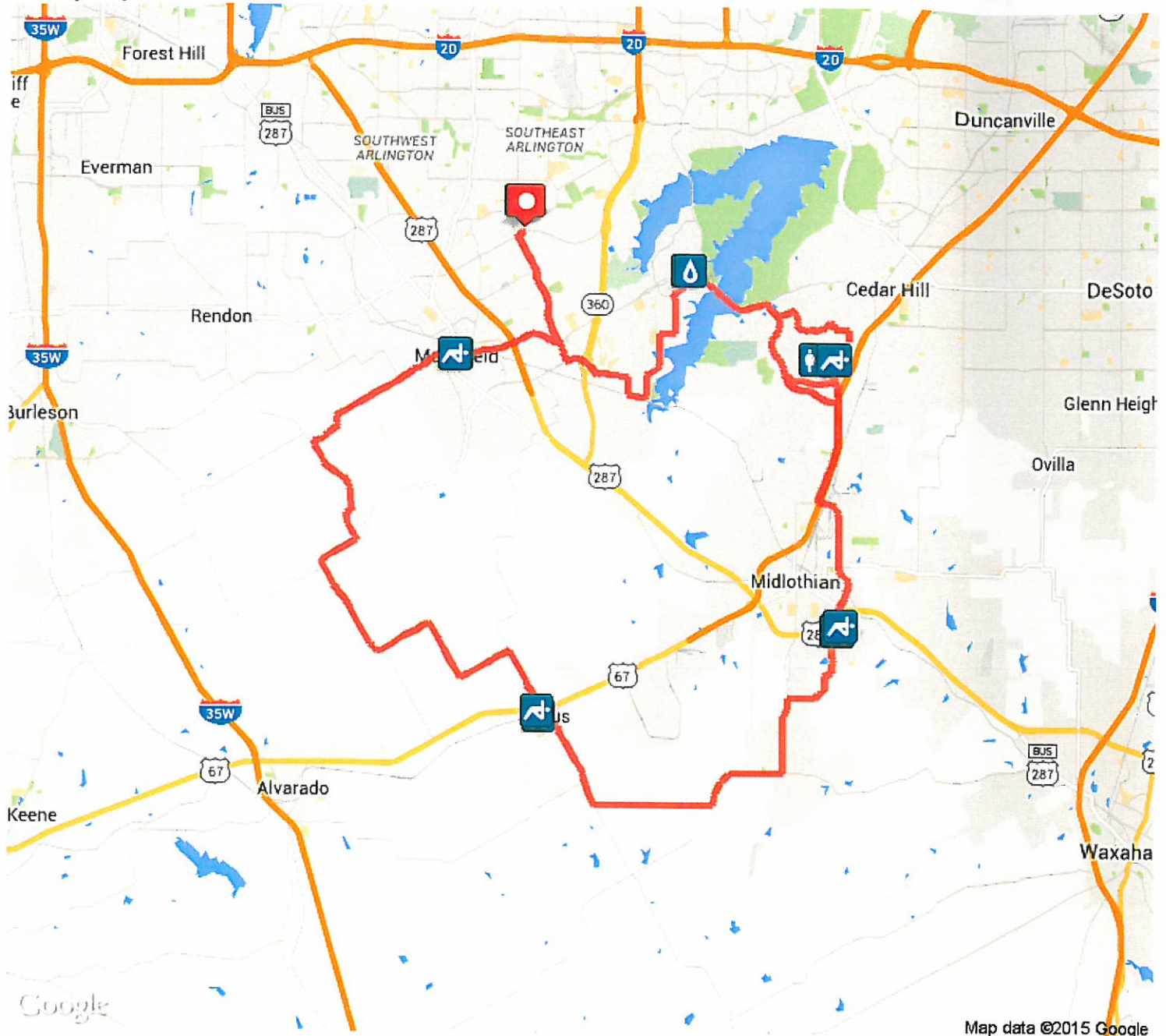


Bike Out Hunger Mansfield 67mi 2015

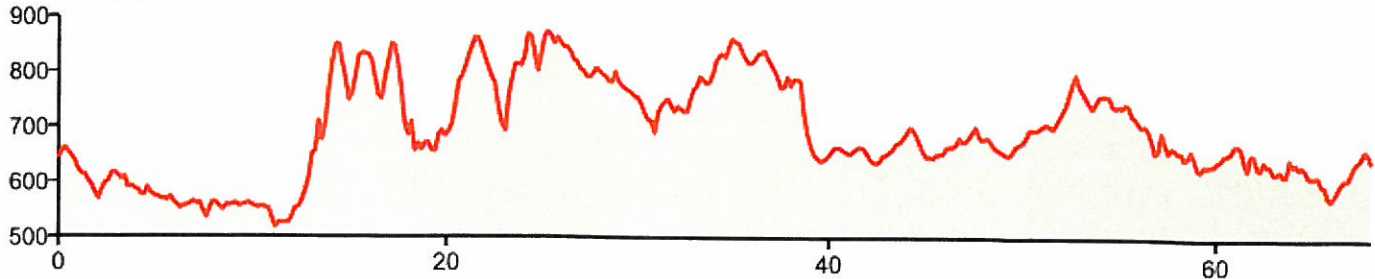

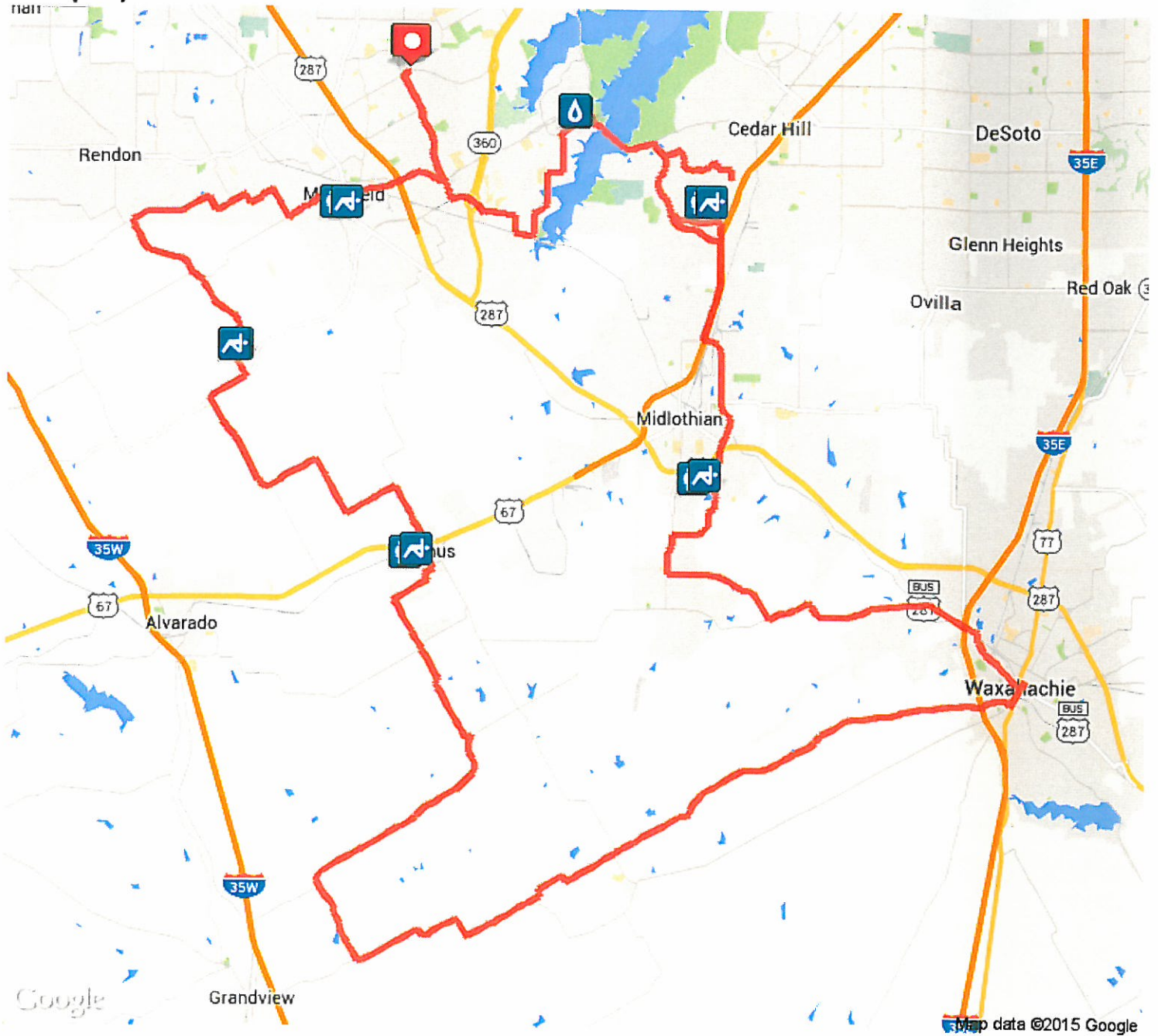


Bike Out Hunger Mansfield 100mi 2015

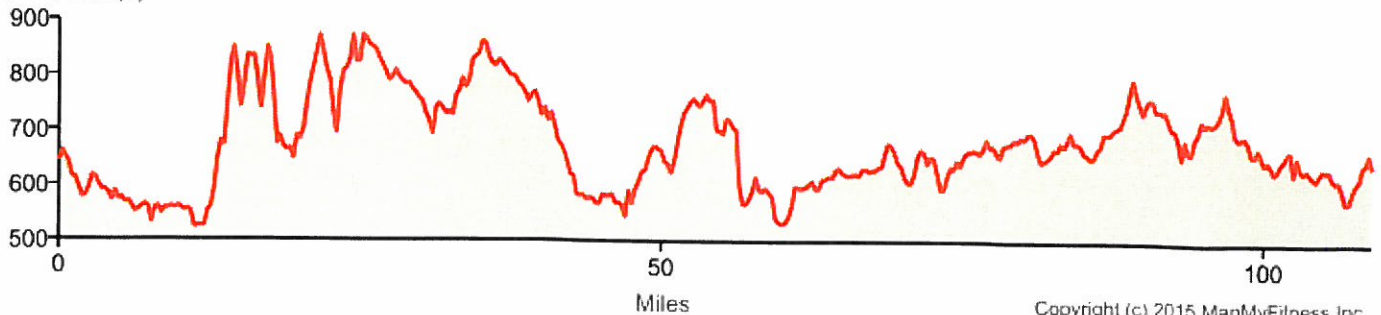
