NOTICE OF VACANCY: On February 22, 2023, Ms. Katherine Wilemon, sent a notice of resignation, via email, to all members of the Tarrant Appraisal District Board of Directors announcing her decision to resign from the Tarrant Appraisal District's Governing Body. Attached is a copy of that resignation notice.

Subsection 6.03 (I) of the Texas Property Tax Code¹ requires a "notification from the board of directors of the existence of the vacancy" be sent to each taxing unit that is entitled to vote under this section.

As provided by Section 6.03 (I), each taxing unit that is entitled to vote for members of the Tarrant Appraisal District board may nominate by resolution, adopted by its governing body, a candidate to fill the vacancy.

Those taxing units desiring to nominate a candidate to fill the vacancy shall submit the name of its nominee to the chief appraiser by midnight April 17, 2023 (the 45th days after the notification from the board of directors of the existence of the vacancy).

¹ Section 6.033 (l) provides:

If a vacancy occurs on the board of directors other than a vacancy in the position held by a county assessor-collector serving as a nonvoting director, each taxing unit that is entitled to vote by this section may nominate by resolution adopted by its governing body a candidate to fill the vacancy. The unit shall submit the name of its nominee to the chief appraiser within 45 days after notification from the board of directors of the existence of the vacancy, and the chief appraiser shall prepare and deliver to the board of directors within the next five days a list of the nominees. The board of directors shall elect by majority vote of its members one of the nominees to fill the vacancy.
