A RESOLUTION OF THE CITY OF MANSFIELD, TEXAS, AMENDING RESOLUTION NO. RE-2762-12 WHICH CALLED FOR A GENERAL ELECTION TO BE HELD ON MAY 12, 2012; BY APPOINTING AN ELECTION JUDGE AND ALTERNATE ELECTION JUDGE, ESTABLISHING A DATE FOR RUNOFF ELECTION, IF NECESSARY, APPROVING A JOINT ELECTION AGREEMENT WITH TARRANT COUNTY ELECTIONS ADMINISTRATOR AND BY AMENDING PRECINCT NUMBERS WITHIN THE CITY, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council approved Resolution Number RE-2762-12 on January 23, 2012 calling for a General Election to be held on May 12, 2012; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

SECTION 1.

Section 6 of Resolution No. RE-2762-12 is hereby amended to read as follows:

AGREEMENT WITH TARRANT COUNTY: The Joint Election Agreement with the Tarrant County Elections Administrator and the City of Mansfield (the “Contract”), attached hereto as Exhibit “A”, is hereby approved for all purposes and the Mayor is authorized to execute the Contract. The Mayor is hereby authorized and directed to take any and all actions necessary to enable the Tarrant County Elections Administrator and the City to conduct the May 12, 2012 General Election in accordance with all applicable law.

SECTION 2.

Section 7 of Resolution No. RE-2762-12 is hereby amended to read as follows:

(a) **ELECTION DAY POLLING PLACE – TARRANT COUNTY:** The polling places for Election Day in Tarrant County shall be as follows:

...

(b) The polling place for City of Mansfield Precinct No. 2 shall include Precinct No. 2435 following redistricting, as required by various sections of the Election Code.

...

Precinct No. 2557 has been incorporated in the newly created Precinct No. 2435; therefore, Precinct No. 2557 shall be deleted following redistricting as required by various sections of the Election Code.

(c) The polling place for City of Mansfield Precinct No. 3 shall include Precinct No. 2618 following redistricting as required by various sections of the Election Code.

SECTION 3.

Section 8 of Resolution No. RE-2762-12 is hereby amended to read as follows:

APPOINTMENT OF ELECTION JUDGES AND ALTERNATE ELECTION JUDGES – TARRANT COUNTY: The following named individuals, are hereby appointed to serve as Presiding Election Judge and Alternate Presiding Election Judges, respectively, at the election:

APPOINTMENT OF ELECTION JUDGES AND ALTERNATE ELECTION JUDGES – JOHNSON COUNTY AND ELLIS COUNTY: The following names individuals, are hereby appointed to serve as Presiding Election Judge and Alternate Presiding Election Judges, respectively, at the election:

The Election Judges and Alternate Presiding Judges shall be qualified voters of the City.

SECTION 4.

Section 13 of Resolution No. RE-2762-12 is hereby amended to read as follows:

RUN-OFF ELECTION: In the event no candidate receives a majority of votes for an office, there shall be a run-off election held on Saturday, June 23, 2012.

SECTION 5.

This Resolution is effective upon approval by the City Council.
