A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, APPROVING PROFESSIONAL SERVICES CONTRACTS WITH TEAGUE NALL AND PERKINS, LLC AND BRITAIN & CRAWFORD, LLC, AND APPROVING FUNDING IN AN AMOUNT NOT TO EXCEED \$1,278,156.00 FOR THE WATSON BRANCH PARALLEL SEWER; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE. (UTILITY FUND)

WHEREAS, the City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,

WHEREAS, the City Council recognizes the need to proceed forward with design of the Watson Branch Parallel Sewer project for the benefit of the citizens of the City of Mansfield; and,

WHEREAS, Teague Nall and Perkins, LLC has provided a proposal for the design of the Watson Branch Parallel Sewer project in an amount not to exceed Six Hundred Seventy-Six Thousand Nine Hundred Fifty-Six and no/100 dollars (\$676,956.00); and,

WHEREAS, Brittain & Crawford, LLC has provided a proposal for survey services for the Watson Branch Parallel Sewer project in an amount not to exceed One Hundred Thirty-Two Thousand and no/100 dollars (\$132,000.00); and,

WHEREAS, after review of the proposal City staff recommends approving professional services contracts with Teague Nall and Perkins, LLC and Brittain & Crawford, LLC; and,

WHEREAS, funding for this contract is available from the Utility Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

SECTION 1.

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

SECTION 2.

A Professional Services Contract with Teague Nall and Perkins, LLC in an amount not to exceed Six Hundred Seventy-Six Thousand Nine Hundred Fifty-Six and no/100 dollars (\$676,956.00) for the design of the Watson Branch Parallel Sewer, in substantially the same form as the attached Exhibit "A", is hereby approved.

SECTION 3.

A Professional Services Contract with Brittain and Crawford in an amount not to exceed One Hundred Thirty-Two Thousand and no/100 dollars (\$132,000.00) for survey services of the Watson Branch Parallel Sewer, in substantially the same form as the attached Exhibit "A", is hereby approved.

SECTION 4.

Additional funding in the amount not to exceed Four Hundred Sixty-Nine Thousand Two Hundred and no/100 dollars (\$469,200.00) for the purchase of right-of-way, easements and other miscellaneous services is hereby approved.

SECTION 5.

It is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law and the public notice of the time, place, and purpose of said meeting was given as required.

SECTION 6.

This Resolution shall be effective from and after its passage.
