THENCE N 38 deg. 42 min. 34 sec. W, a distance of 258.58 feet to a point for corner in the center of said Mansfield-Webb Road;

THENCE N 59 deg. 42 min. 40 sec. E, along the center of said Mansfield-Webb Road, a distance of 557.93 feet to a point for corner;

THENCE S 30 deg. 19 min. 02 sec. E, passing at a distance of 25 feet, the west corner of Lot 1, Block 1 of Northside Church of Christ, an addition to the City of Mansfield, according to the plat thereof, recorded in Cabinet B, Slide 2557, P.R.T.C.T., continuing along the southwest line of said Lot 1, for a total distance of 233.13 feet to a point for corner, being the south corner of said Lot 1;
