A RESOLUTION AUTHORIZING THE CITY MANAGER AND THE POLICE DEPARTMENT TO MAKE APPLICATION(S), RECEIVE, AND EXPEND GRANT FUNDING FROM THE CRIMINAL JUSTICE DIVISION (CJD) OF THE GOVERNOR'S OFFICE OF THE STATE OF TEXAS FOR CRIMINAL JUSTICE PROJECTS THAT REDUCE CRIME AND IMPROVE THE CRIMINAL JUSTICE SYSTEM DURING THE FY2016 IN AN AMOUNT NOT TO EXCEED \$240,000 WITH NO MATCH REQUIRED.

**WHEREAS**, the City of Mansfield and the police department is a unit of local government that meets the criteria established by the CJD and the State of Texas to apply for and receive grant funds under this program; and

**WHEREAS**, the City of Mansfield and the police department is eligible for an amount not to exceed \$80,000 per project, with a maximum of \$240,000 (3 projects) in grant program funding with no match required; and

**WHEREAS,** the City of Mansfield and the police department agrees to comply with all program rules as set out in the grant program guidelines; and

**WHEREAS,** the City of Mansfield agrees that in the event of loss or misuse of the Criminal Justice Division funds, the City of Mansfield assures that the funds will be returned to the Criminal Justice Division in full; and

**WHEREAS**, the City of Mansfield designates Clayton W. Chandler (City Manager) as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency.

**WHEREAS**, the City Council desires to ratify and authorize the City Manager and the police department to make application(s), receive and expend the above mentioned grant allocation, if awarded.

## NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

## **SECTION 1.**

- 1. The City Manager or designee is authorized to execute all documents and make application(s) for obtaining state funds from CJD through the State of Texas in FY 2016 for equipment needs as follows:
  - a. Shooting simulator
  - b. Rapid deployment vehicle
  - c. Hand held and mobile communication radios
