WHEREAS, throughout the project, staff has determined that additional scope is required to ensure successful completion of the project; and,

WHEREAS, Halff Associates, INC. has provided City staff with a change order in the amount of \$76,500 to cover the cost of the additional scope of the project; and,

WHEREAS, after review City staff recommends the change order to accommodate the requested additional scope of the project; and,

WHEREAS, funding for this change order is available from the Drainage Utility Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

SECTION 1.

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.
