**A RESOLUTION AUTHORIZING FUNDING IN AN AMOUNT NOT TO EXCEED \$643,540 AND APPROVAL OF A PROFESSIONAL SERVICES CONTRACT BETWEEN THE CITY OF MANSFIELD, TX AND WIER AND ASSOCIATES, INC. IN AN AMOUNT NOT TO EXCEED \$393,540 FOR THE DESIGN OF DICK PRICE ROAD EAST OF UPRR TO N. MAIN STREET. FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE (STREET BOND FUND, TARRANT COUNTY TRANSPORTATION BOND PROGRAM)**

**WHEREAS**, The City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,

**WHEREAS**, the City Council recognizes the need to proceed forward with design of Dick Price Road East of UPRR to N. Main Street; and,

**WHEREAS**, Wier and Associates, Inc. has provided a proposal for the design in an amount not to exceed three hundred ninety-three thousand five hundred forty and no/100 dollars (\$393,540.00); and,

**WHEREAS**, after review of the proposal City staff recommends approving a professional services contract with Wier and Associates, Inc.; and,

**WHEREAS**, funding for this contract is available from the Street Bond Fund and Tarrant County Transportation Bond Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:**

**SECTION 1.**

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

**SECTION 2.**

A Professional Services Contract with Wier and Associates, Inc. in an amount not to exceed three hundred ninety-three thousand five hundred forty and no/100 dollars (\$393,540.00) for the design of Dick Price Road East of UPRR to N. Main Street and, in substantially the same form as the attached Exhibit "A", is hereby approved.

**SECTION 3.**

Funding in an amount not to exceed two hundred fifty thousand and no/100 dollars (\$250,000.00) for the valuation and acquisition of right-of-way necessary to construct the project

is hereby approved.

**SECTION 4.**

It is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law and the public notice of the time, place, and purpose of said meeting was given as required.

**SECTION 5.**

This Resolution shall be effective from and after its passage.
