A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, APPROVING A PROFESSIONAL SERVICES CONTRACT BETWEEN THE CITY OF MANSFIELD, TX AND WIER & ASSOCIATES, INC. IN AN AMOUNT NOT TO EXCEED \$311,130.00 FOR THE DESIGN AND SURVEY OF HERITAGE PARKWAY EASTBOUND LANES RECONSTRUCTION (SOUTH MAIN ST. TO COMMERCE DR.); FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE (STREET BOND FUND)

WHEREAS, The City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,

WHEREAS, the City Council recognizes the need to proceed forward with the design and survey of Heritage Parkway Eastbound Lanes Reconstruction (South Main St. to Commerce Dr.); and,

WHEREAS, Wier & Associates, Inc. has provided a proposal for the design and survey of Heritage Parkway Eastbound Lanes Reconstruction (South Main St. to Commerce Dr.) in an amount not to exceed Three Hundred Eleven Thousand One Hundred Thirty and 00/100 dollars (\$311,130.00); and,

WHEREAS, after review of the proposal City staff recommends approving a professional services contract with Wier & Associates, Inc.; and,

WHEREAS, funding for this contract is available from the Street Bond Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

SECTION 1.

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

SECTION 2.

A Professional Services Contract with Wier & Associates, Inc. in an amount not to exceed Three Hundred Eleven Thousand One Hundred Thirty and 00/100 dollars (\$311,130.00) for the design and survey of Heritage Parkway Eastbound Lanes Reconstruction (South Main St. to Commerce Dr.), in substantially the same form as the attached Exhibit "A", is hereby approved.
