#### **Requested Action**

To consider the proposed request for an extension.

#### Recommendation

The Department of Planning and Development Services recommends approval.

## **Description/History**

Texas state law mandates that a city must take action on a plat application within 30 days of its receipt. This action requires the plat to be either approved, denied, or approved with conditions by the designated approval authority within that timeframe.

The preliminary plat application for Case No. SD#24-053 was received on December 6, 2024, which means a decision must be made by January 5, 2025. However, due to the number of review comments on this plat, the applicant is unable to make the necessary corrections within the 30-day period. Therefore, the applicant has requested a 30-day extension to allow adequate time for revisions. This extension must be approved by the city.

The request for an extension is now being submitted to the Planning and Zoning Commission for review and approval, as the city's highest authority for plat approval. Please note that the Commission is only considering the request for an extension at this time to comply with state law. The plat application will be brought to the Commission for review at an upcoming meeting.
