**A RESOLUTION OF THE MANSFIELD CITY COUNCIL ADOPTING AMENDED GUIDELINES FOR THE ALLOCATION OF CITY OF MANSFIELD HOTEL/MOTEL OCCUPANCY TAX FUNDS.**

**WHEREAS**, the opening of hotels in the city of Mansfield has provoked the development of guidelines to be administered by the City Secretary's Office; and

**WHEREAS**, the City Council recognizes that guidelines are imperative to the successful allocation of hotel/motel occupancy funds; and

**WHEREAS**, the City Council of the City of Mansfield, Texas adopted Resolution No. RE-2503-09 on the 13<sup>th</sup> day of April, 2009 adopting guidelines for the allocation of hotel/motel occupancy tax funds; and

**WHEREAS**, the City Council of the City of Mansfield, Texas adopted Resolution No. RE-2710-11 on the 13<sup>th</sup> day of June, 2011 amending the guidelines for the allocation of hotel/motel occupancy tax funds; and

**WHEREAS**, the City Council of the City of Mansfield, Texas adopted Resolution No. RE-2843-12 on the 10<sup>th</sup> day of September, 2012 amending the guidelines for the allocation of hotel/motel occupancy tax funds; and

**WHEREAS**, the City Council of the City of Mansfield, Texas adopted Resolution No. RE-2896-13 on the 22<sup>nd</sup> day of April, 2013 amending the guidelines for the allocation of hotel/motel occupancy tax funds; and

**WHEREAS**, the City Council of the City of Mansfield, Texas adopted Resolution No. RE-3115-15 on the 26<sup>th</sup> day of May, 2015 amending the guidelines for the allocation of hotel/motel occupancy tax funds; and

**WHEREAS**, the City Council of the City of Mansfield, Texas recognizes that it is in the best interest of the citizens of the City of Mansfield that the guidelines be amended as provided herein to better serve the citizens of Mansfield; and

**WHEREAS**, after review and deliberation of all facts therein, it is the consideration of the City Council that it is in the best interest of public health, safety and welfare that the City amends the Guidelines for the Allocation of City of Mansfield Hotel/Motel Occupancy Tax Funds.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:**

**SECTION 1.**

The City Council hereby approves the attached amended guidelines set forth as "Exhibit A".

**SECTION 2.**

That this resolution shall become effective immediately upon its passage.
