A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, APPROVING THE AWARD OF A CONSTRUCTION MANAGER AT RISK (CMAR) CONTRACT TO ARCHER WESTERN CONSTRUCTION, LLC., FOR THE BUD ERVIN WATER TREATMENT PLANT PHASE V EXPANSION; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE (UTILITY FUND)

**WHEREAS**, The City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,

**WHEREAS**, the City Council previously authorized the use of the Construction Manager at Risk (CMAR) method for the construction of the Bud Ervin Water Treatment Plant Phase V Expansion (Project) in the City of Mansfield, Texas, and found that the CMAR method would provide best value for the City; and,

**WHEREAS**, the City issued a Request for Proposal (RFP) 2023-41-04-05 seeking a qualified CMAR to provide design phase assistance and complete construction phase services for the Project; and,

**WHEREAS**, Archer Western, LLC has provided a response to the RFP demonstrating extensive experience in providing CMAR services; and,

**WHEREAS**, after review of all the proposals City staff recommends the selection of Archer Western, LLC for the CMAR on the Project; and,

**WHEREAS**, funding for this contract is available from the Utility Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

## **SECTION 2.**

A contract for the CMAR services for the Project with Archer Western, LLC. in the amount not to exceed \$393,400 for the Pre-Construction Phase is hereby approved.

The City Council hereby delegates authority under Texas Government Code Chapter 2269 to the City Manager, delegates the City Manager as its designated representative for
