WHEREAS, Church of Christ in Mansfield, acting by and through the undersigned, its duly authorized agent, is the sole owner of all that certain tract, parcel, or lot of land located in the William Lynn Survey, Abstract No. 984, City of Mansfield, County of Tarrant, Texas, according to the deed recorded in D21104108, Deed Records, Tarrant County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2" iron found at the Southwest corner of said tract, also being the Northeast corner of Lot 1, Block 1, Daugherty Addition as recorded in Vol. 388-141, page 32, P.R.T.C.T.;

THENCE North 01°04'14" East a distance of 90.59 feet along the West line of said Church of Christ in Mansfield tract to a 1/2" iron found;

THENCE North 01°40'30" East a distance of 174.45 feet along the West line of said Church of Christ in Mansfield tract to a 3/8" pipe found at the most Westerly Northwest corner of said Church of Christ in Mansfield tract;

THENCE South 85°54'44" East a distance of 184.23 feet along a North line of said Church of Christ in Mansfield tract to a 3/4" iron found;

THENCE North 06°01'35" East a distance of 158.14 feet along a West line of said Church of Christ in Mansfield tract to a 1/2" iron found at the most Northerly Northwest corner of said Church of Christ in Mansfield tract, said iron also being on the South line of CALLENDER Road (right-of-way varies);

THENCE along said right-of-way 329.40 feet along a curve to the right, said curve having a central angle of 73°32'34", a radius of 256.63 feet, a chord of 307.25 feet and a chord bearing of South 48°54'21" East to a 1/2" iron found;

THENCE along said right-of-way South 11°52'56" East a distance of 128.32 feet to a 5/8" iron found;

THENCE along said right-of-way South 12°06'19" East a distance of 93.07 feet 1/2" iron found;

THENCE North 88°53'00" West a distance of 484.74 feet along the South line of said Church of Christ in Mansfield tract to the POINT OF BEGINNING and containing 3.278 acres.

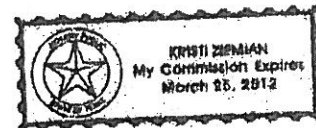
