NOTICES

Your Special Event Permit is approved with the following stipulations:

- 1. All items must be placed at the location as depicted on the approved site plan.
- 2. Fire Hydrants and Fire Lanes must not be blocked.
- 3. Pop-Up type canopies are allowed. Temporary Tents are not allowed to be set up unless a Temporary Tent Permit was applied for and approved. A separate permit for the Tent will be issued, if applicable.
- 4. No Promotional Signs (banners, streamers, wind signs, balloons, etc.) are allowed to be placed unless a Promotional Sign Permit was applied for and approved. A separate permit for the Promotional Signs will be issued, if applicable.
- 5. For any outdoor music or speaker amplification (if applicable), you simply follow the noise ordinance. This permit does not give you permission to disobey any city rules and regulations. The noise ordinance is still applicable and is enforced through the Mansfield Police Department.

130.7.2 Noises Disrupting the Peace-Radios, phonographs and the like. The use or operation of any radio receiving set, musical instrument, phonograph or other machine or device for the producing or reproducing of sound in such manner as to disturb the peace, quiet and comfort of the neighboring inhabitants or at any time with louder volume than is necessary for convenient hearing for the person of normal hearing who is in the room, vehicle or chamber in which the machine or device is operated and who is a voluntary listener there to or allowing the use or operation. The operation of any set, instrument phonograph, machine or device between the hours of 11:00 p.m. and 7:00 a.m. in a manner as to be plainly audible at a distance of 50 feet from the building, structure or vehicle in which it is located shall be prima facie evidence of a violation of this section. Penal Code-Title 9 Chapter 42.01 (a) (5) makes unreasonable noise in a public place other than a sport shooting range, as defined by Section 250.001, Local Government Code, or in or near a private residence that he has no right to occupy.
