- 2. N30°44'15"W, a distance of 275.00 feet to an X set in the South line of a tract of land described in the permanent right-of-way to the City of Mansfield, recorded in Volume 12916, Page 229, Deed records, Tarrant County, Texas being the Northeast corner of said Lot 1;

THENCE N59°18'58"E, a distance of 706.68 feet along said South line of said City of Mansfield tract to a point at the Northwest corner of a Permanent Right-of-Way to the City of Mansfield as described in the deed recorded in County Clerk's Document Number D210205991, Deed Records, Tarrant County, Texas;

THENCE along the West and South lines of said Permanent Right-of-Way as follows:
