**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, AWARDED CONTRACTS FOR THE CONSTRUCTION OF EAST BROAD STREET STORM DRAIN IMPROVEMENTS (700 BLOCK MAIN REPLACEMENT) TO RW JONES HEAVY CONSTRUCTION, LLC, FOR CONSTRUCTION, TO BRITAIN AND CRAWFORD, LLC FOR SURVEYING, AND TO RABA KISTNER, INC, FOR MATERIAL TESTING, FOR AN AMOUNT NOT TO EXCEED \$412,514.00; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE. (DRAINAGE UTILITY FUND)**

**WHEREAS**, the City of Mansfield (City) is a home rule municipality operating under and governed by the laws and Constitution of the State of Texas; and,

**WHEREAS**, the City of Mansfield has publicly advertised and requested competitive bids for the construction of East Broad Storm Drain Improvements (700 Block Main Replacement); and,

**WHEREAS**, all bids were received, opened and publicly read aloud on September 26, 2017; and,

**WHEREAS**, it is recognized that it is in the best interest of the citizens of the City of Mansfield that the construction provided for herein be started at the earliest possible date to ensure necessary service and delivery; and,

**WHEREAS**, after review of all bids received, City staff believes that the "lowest and best" bid is that of RW Jones Heavy Construction, LLC; and,

**WHEREAS**, funding for this contract is available from the Drainage Utility Fund.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:**

**SECTION 1.**

The findings and recitations set out in the preamble are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

**SECTION 2.**

A Construction Contract with RW Jones Heavy Construction, LLC. in an amount not to exceed Three Hundred Ninety-Four Thousand, Five Hundred Fifty-One and 30/100 dollars (\$394,551.30), including a 10% contingency, for the construction of the East Broad Street Storm Drain Improvements (700 Block Main Replacement) is hereby approved.

**SECTION 3.**

Additional funding in the amount of \$17,962.70 (Seventeen Thousand Nine Hundred Sixty-Two and 70/100 for, survey, or material testing services is hereby approved.

**SECTION 4.**

This Resolution shall be effective from and after its passage.
