

## FIELD NOTES - DESCRIPTION RIGHT-OF-WAY ABANDONMENT

BEING A TRACT OF LAND LOCATED IN THE RICHARD BRATTON SURVEY, ABSTRACT NO. 114, TARRANT COUNTY, TEXAS, BEING A PORTION OF THE PRESCRIPTIVE RIGHT-OF-WAY OF MILLER ROAD (PREVIOUSLY KNOWN AS SEETON ROAD OR COUNTRY ROAD NO. 2020), AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT A TEXAS DEPARTMENT OF TRANSPORTATION (TXDOT) MONUMENT FOUND AT THE INTERSECTION OF THE NORTHEAST RIGHT-OF-WAY LINE OF SAID MILLER ROAD WITH THE WEST RIGHT-OF-WAY LINE OF STATE HIGHWAY NO. 360 (A VARIABLE WIDTH RIGHT-OF-WAY), SAID TXDOT MONUMENT BEING THE SOUTH CORNER OF LOT 2R1B, BLOCK 1, THR RTC, AN ADDITION TO THE CITY OF MANSFIELD, TARRANT COUNTY, TEXAS, ACCORDING TO THE PLAT RECORDED IN INSTRUMENT NUMBER D221061652, OFFICIAL PUBLIC RECORDS, TARRANT COUNTY TEXAS, (O.P.R.T.C.T.);

THENCE S 22°01'57" W, DEPARTING THE NORTHEAST RIGHT-OF-WAY LINE OF SAID MILLER ROAD AND ALONG THE WEST RIGHT-OF-WAY LINE OF SAID STATE HIGHWAY NO. 360, A DISTANCE OF 28.62 FEET TO A POINT, BEING THE SOUTHEAST CORNER OF A TRACT OF LAND DESCRIBED IN QUITCLAIM DEEDS RECORDED IN INSTRUMENT NUMBERS D217117803 AND D217117804, O.P.R.T.C.T.;

THENCE N 30'43'08" W, ALONG THE NORTHEAST LINE OF SAID QUITCLAIM TRACTS, A DISTANCE OF 348.75 FEET TO A POINT;

THENCE N 59°00'00E E, A DISTANCE OF 21.90 FEET, TO A POINT BEING THE SOUTH CORNER OF LOT 2R1, BLOCK 1, OF SAID THR RTC ADDITION, AND THE WEST CORNER OF LOT 2R1B, BLOCK 1;

THENCE S 30°52'20" E, ALONG THE NORTHEAST RIGHT-OF-WAY LINE OF SAID MILLER ROAD AND THE SOUTHWEST LINE OF SAID LOT 2R1B, A DISTANCE OF 331.54 FEET TO THE PLACE OF BEGINNING AND CONTAINING 0.175 ACRES (7,603 SQUARE FEET) OF LAND, MORE OR LESS.
