##### Discussion Regarding the Street Capital Improvement Program

Ms. Stevenson spoke on Mansfield demographics, data collection and analysis, density, travel estimates, funding programs, and an estimated implementation schedule for the on-demand microtransit project. Wayne Gensler, Chief Operating Officer for Trinity Metro, gave a presentation on Mansfield Zipzone. Mr. Gensler spoke on zipzone, VIA, Mansfield transit usage/trends, the Mansfield proposal, and answered Council questions.*
