- 3517 St. Paul Road modified L-Plan constructed around 1895
- 140 N Mitchell Road Stephens Family Cemetery
- 941 W Debbie Lane Grimsley Cemetery
- 4200 Britton Road United Methodist Church
- 4239 Britton Road Britton Co-Op Cotton Gin
- 4350 Britton Road- 1915 commercial building
