RESOLUTION AUTHORIZING AN **ENGINEERING** Α SERVICES AGREEMENT WITH ALAN **PLUMMER** ASSOCIATES INC FOR CONSTRUCTION ADMINISTRATION SERVICES RELATING TO THE 3.5 MILLION GALLON CLEARWELL PROJECT AND FOR DESIGN AND CONSTRUCTION ADMINISTRATION SERVICES FOR THE 36" UPPER PRESSURE PLANE FINISHED WATER PIPELINE PROJECT FOR AN AMOUNT NOT TO EXCEED \$998,502.00.

WHEREAS, the CITY owns and operates the Bud Ervin Water Treatment Plant (hereinafter called "Plant"), which supplies water to the CITY's customers; and

WHEREAS, the CITY intends to construct the 3.5 Million Gallon Clearwell Project that includes a low-pressure plane high service pump, surge tank, and rehab to the mechanical and electrical controls (hereinafter referred to as "PROJECT 1"); and

WHEREAS, the CITY desires to obtain engineering services in connection with the construction administration of PROJECT 1; and

WHEREAS, the CITY desires to obtain engineering services in connection with the design and construction of the 36" Upper-Pressure Plane Finished Water Pipeline (hereinafter referred to as "Project 2"; and

WHEREAS, the City Council of the City of Mansfield, Texas has determined it to be in the best interest of the Citizens of the City of Mansfield to enter into an engineering services agreement for Project 1 and Project 2.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MANSFIELD, TEXAS, THAT:

#### SECTION 1.

Funding is hereby authorized in the amount of six hundred forty-eight thousand eight hundred fifty-seven dollars and 0/100 cents (\$648,857.00) for engineering services related to the construction of project 1.

# SECTION 2.

Funding is hereby authorized in the amount of two hundred fifty-two thousand four hundred seventy dollars and 0/100 cents (\$252,470.00) for engineering services related to design and construction of Project 2.

### SECTION 3.

Funding is hereby authorized in the amount of ninety-seven thousand one hundred seventy-five dollars and 0/100 cents (\$97,175.00) for engineering services related to the project management of Projects 1 and 2.

# SECTION 4.

The City Manager is hereby authorized and directed to execute contractual documents with Alan Plummer Associates, Inc., for engineering services related to the construction of Project 1, and engineering services related to the design and construction of Project 2 at a total cost not to exceed nine hundred ninety-eight thousand five hundred two dollars and 00/100 cents (\$998,502.00).
