

**A RESOLUTION OF THE CITY OF MANSFIELD, TEXAS, AUTHORIZING FUNDING IN AN AMOUNT NOT TO EXCEED \$725,000.00 AND AUTHORIZING THE CITY MANAGER TO ENTER INTO INTERLOCAL AGREEMENTS WITH TARRANT COUNTY FOR THE ASPHALT RECONSTRUCTION OF BRECKENRIDGE ROAD, GERTIE BARRETT ROAD FROM TURNER WARNELL ROAD TO CAGLE CROW ROAD, BONNER DRIVE AND AN ASPHALT MILL AND OVERLAY OF SPEERS DRIVE**

**Whereas**, it is recognized that it is in the best interest of the citizens of the City of Mansfield to enter into an Agreement with Tarrant County to reconstruct Breckenridge Road, a portion of Gertie Barrett Road, Bonner Drive and an asphalt mill and overlay of Speers Drive, and

**Whereas**, Tarrant County and the City of Mansfield are both governmental entities engaged in the purchase of goods and services, which is a recognized governmental function; and

**Whereas**, the Interlocal Act contained in Chapter 791 of the Texas Government Code provides legal authority for parties to enter into this agreement, and

**Whereas**, Tarrant County and the City of Mansfield have agreed to said terms of the Agreement, and

**Whereas**, the City of Mansfield and Tarrant County have agreed to contract with each other to reconstruct Breckenridge Road, a portion of Gertie Barrett Road, Bonner Drive and an asphalt mill and overlay of Speers Drive.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MANSFIELD, TEXAS:**

**SECTION 1.**

Funding is hereby authorized in the amount of Seven Hundred Twenty Five Thousand and 00/100 Dollars (\$725,000.00) to construct the roadway improvements. Funding the reconstruction of Breckenridge Road, Gertie Barrett Road and Bonner Drive will be from the Street Bond Fund in the amount of Six Hundred Eighty Six Thousand Six Hundred Twenty and 00/100 Dollars (\$686,620.00). Funding for mill and overlay of Speers Drive will be from the Street Operations General fund in the amount of Thirty Eight Thousand Three Hundred Eighty and 00/100 Dollars (\$38,380.00).

**SECTION 2.**

The City Manager or his designee is hereby authorized and directed to execute an Interlocal Agreement with Tarrant County to reconstruct Breckenridge Road, a portion of Gertie Barrett Road, Bonner Drive and an asphalt mill and overlay of Speers Drive.
