





TEMPORARY FIELD USAGE AGREEMENT

- WHEREAS, THIS TEMPORARY FIELD USAGE AGREEMENT (the "Agreement") is entered into effective as of the 14th day of September, 2019 by and between Fabulous Faith Foundation and MANSFIELD INDEPENDENT SCHOOL DISTRICT, (the "Owner"), together referred to herein as the "Parties", Vernoon Newsom Stadium Parking Lot
- WHEREAS, Organization will hold the Fabulous Faith 5K
- WHEREAS, Owner desires to provide provide parking lot necessary for the Event by authorizing the Organization's users to hold 5K on the Owner's property that is on the Vernon Newsom Stadium (the "Property").

NOW THEREFORE, Club and Owner hereby agree as follows:

- 1. Ownership and Term. The Parties acknowledge and agree that the land upon which the Property is located is Owner's property and shall remain Owner property regardless of the Event and any improvements Club makes on or to the Property as a part of the Event. Owner makes no representations or warranties of suitability or title concerning the land. Club may use the Property, for stated fees (see attached cost estimate) for the purposes set forth herein for a term of 5:45 through 7:00 PM on stated days, unless terminated sooner pursuant to Paragraph 3
- 2. <u>Parking on Owner's Property</u>. Owner hereby agrees to allow Club the full rights of ingress and egress to the Property and to use the Property for parking and for 5K Event. In addition, Owner hereby agrees to allow the Club the right to access the Property in the manner the Club believes to be in the best interest of public safety.
- 3. At all times during the term of this Agreement, Club shall use the Property solely to provide parking and running for the Event. Owner specifically understands and agrees that Owner shall not block the use of, or restrict access to, any part or portion of the Property during the term of this Agreement, except as specifically authorized in writing by the Club prior to any such occurrence.

Notwithstanding the foregoing, the use granted to Club under this Agreement shall immediately terminate if Club violates any of the terms or conditions of this Agreement.

4. <u>Insurance</u>. League shall provide certificates of insurance covering the use of the Property in amounts and coverages acceptable to Owner. League shall include the Property and

Owner in the coverage afforded by its general liability policy and property damage policy and list Owner as an additional insured on such policies. Before August 29, 2017 the Club shall provide Owner with a copy of the insurance certificates and other necessary documentation to show that the insurance requirements of this Agreement have been met.

- 5. Landscaping and Maintenance. The League shall be solely responsible for restoring the Property to the same conditions that existed prior to the Event ("Restoration"). For example, the League shall be solely responsible for the repair of areas of the Property or any adjacent Owner property damaged by League's users, replacement of any tree, bush or shrub disturbed or destroyed by League's users with a comparable item, and removal of all trash or detritus from the Property. Restoration shall be completed within five (5) days of the Event, unless the Owner agrees in writing to extend the time that the League can restore the Property.
- 6. <u>Indemnification</u>. To the extent allowed under applicable law, Organization shall indemnify and hold harmless Owner from and against any and all claims, demands and suits arising from the use of the Property, if any, including all court costs and attorneys' fees.
- 7. <u>Assignment.</u> This Agreement shall not be assigned or transferred in whole or in part without the previous written permission of the Owner. Any attempt to assign or transfer any right, duty or obligation that arises under this Agreement without the Owner's prior written approval shall be void.
- 8. <u>Waiver.</u> Failure to insist upon strict compliance with any of the terms, covenants or conditions hereof, in whole or in part, shall not be deemed a waiver of such term, provision, covenant or condition or portion thereof, nor shall any waiver or relinquishment of any right or power at any one or more times be deemed a waiver or relinquishment of such right or power at any other time or times as to any party to this Agreement

Miscellaneous.

- a. This Agreement expresses the entire agreement between the parties hereto regarding the subject matter contained herein and may not be modified or amended except by written agreement duly executed by both parties.
- b. This Agreement shall be construed and enforced in accordance with the laws of the State of Texas, and venue for all purposes hereunder shall be in Tarrant County, Texas.

- c. If any provision of this Agreement is determined by any court of competent jurisdiction to be invalid, illegal or unenforceable, such provision shall be fully severable herefrom and the remainder of this Agreement shall be fully enforced.
- d. It is expressly understood and agreed that, in the execution of this Agreement, the parties do not waive, nor shall they be deemed hereby to have waived any immunity or defense that would otherwise be available to them against claims arising in the exercise of governmental powers and functions. By entering into this Agreement, the parties do not create any obligations, express or implied, other than those set forth herein, and this Agreement shall not create any rights in parties not signatories hereto.
- This Agreement is intended for the benefit of the parties listed and no rights or e. interest in this Agreement shall extend to any third party.
