1. **CALL TO ORDER**

The meeting was called to order by President Suzonne Evans at 6:00 pm.

4. **REPORT OF THE CITY LIBRARIAN**

Library Board Appointments: Steve Standefer welcomed three new members to the Library Advisory Board, inviting all members to introduce themselves in roundtable fashion. The Advisory Board now has 9 sitting members.

Friends of the Library. Friends president Carol Ann Grantham advised that the 2017's Mansfield Reads event will be April 28 at the Library.

Staff Reports. Mr. Standefer advised the Board that Adult Services Librarian Tiffany Daubitz abruptly resigned in August and the search for her replacement has been in progress since that time. A replacement has been found and will start work October 26th. Faria Marin will be introduced to the Board at the November meeting.

Youth Services Librarian Yolanda Botello summarized the summer reading figures for 2016. A written report will be made available at the November meeting along with progress on the Library Family Place project.

FY 2017 Budget. Mr. Standefer handed out copies of the newly adopted Library Budget for FY 2017, which began October 1st. The handout compares the new budget with FY 2016, highlighting the difference and showing an approximate 6% increase over the previous year.

November Meeting. Mr. Standefer advised the Board that officer elections for 2017 will be held at the next meeting and suggested that an orientation for the new members be held at that time. He also suggested that having orientation in this manner would serve as a review for returning members and would allow participation by the whole group.
