## Meeting Minutes - Final

#### REGULAR MEETING

#### 4:00 P.M. - CALL MEETING TO ORDER

*Mayor Cook called the meeting to order at 4:05 p.m.*

**Present** 7 - David Cook; Larry Brose; Brent Newsom; Terry Moore; Julie Short; Mike Leyman and Casey Lewis

#### WORK SESSION TO BE HELD IN THE MULTI-PURPOSE ROOM

##### Discussion Regarding Man House

*Mayor Cook turned the work session over to Lisa Sudbury, Interim Director of Planning, who introduced Fred Cauble, the architect who has been working on plans for the Man house.*

*Mr. Cauble reviewed the work to be done and the costs. He recommended four phases: stabilization of the homestead and barn, restoration of the homestead (air conditioning, lighting, ADA compliance) and barn (an ADA-compliant elevated walkway and ramps), public use areas (toilets, visitor center, and amphitheater), and public use (additional educational structures).*

*He estimated costs for the house for phase 1 at \$154,256.85 and phase 2 at \$163,845. He estimated costs for the barn phase 1 at \$40,450 and phase 2 at \$71,465. The total estimate for both phases of the house and barn is \$441,208.35. He estimated the cost for the visitor center and restrooms to be \$528,000 and the amphitheater to be \$155/square foot. Mr. Cauble noted that no estimate has been made for a parking lot or utility extensions to the property. He also estimated that moving the cabin from the Cook property to the Man property at about \$37,000. Mr. Chandler said there is also a cabin from the McKnight property.*

*Staff was instructed to follow up on possibly finding grants to help with the restoration costs before any allocation is made.*

##### Discussion Regarding Dog Park

*Matt Young, Parks Director, gave an overview of the background of the dog park project. He asked the council if they want a dog park. Councilmembers Leyman and Short said they do not support a dog park. Mr. Young answered questions about the proposed dog park and funding. He noted that most cities have dog parks and that this is the most requested amenity he receives. He added that a public hearing was held on March 20, 2018 and an online survey was also done to get public input. He*

*broke down the costs for the dog part as \$25,000 for the master plan, \$50,000 for construction documents, \$280,000 for the parking lot, including walkways, water, and fencing, and \$450,000 for the park itself. He added that maintenance and operations costs for the park would be equivalent to those of a typical neighborhood park.*

*Mr. Young reviewed the proposed site plan for a dog park at the Man property, noting that this location allows for future connection to the Walnut Creek Linear Trail Extension. He also said this site did not rank high on the list for a proposed veteran's memorial. Mr. Young said that if the council chooses not to do a dog park, the Parks Board will use the funds for another of their projects.*
