#### SD#18-032: Public Hearing on a replat to create Lot 1R1A and Lot 3, Block 1, Lee's Broad Addition

The applicant was not available. Ms. Sudbury gave a brief overview of the request.

Chairman Wilshire opened the public hearing and called for anyone wishing to speak to come forward.

Seeing no one come forward to speak, Chairman Wilshire closed the public hearing.

ZC#18-021: Public Hearing for zoning change from PR, Pre-Development District to PD, Planned Development District for I-1, Light Industrial uses on approximately 241.69 acres, generally located at the northwest corner of Lone Star Road and S. Miller Road; the northeast corner of Britton Road and S. Miller Road; and south of Lone Star Road and Britton Road approximately 660 feet east of SH 360 and approximately 1500 feet west of S. Holland Road

Clayton Strolle, representing the applicant, gave an overview of the request, power point presentation and video presentation of the proposed buildings and future roadways. He stated that the development will consist of seven buildings and constructed in 3 phases. He also noted that he is currently working with staff on truck traffic, drainage and showed a list of potential tenants. Rob Miller, Kent Newsom and Scott Meyer, also representing the applicant, spoke in support of the request noting the need for this type of state of the art distribution center.

Chairman Wilshire opened the public hearing and called for anyone wishing to speak to come forward.

Dan Massey, Jim Wagnon, Kathleen Francis, Samuel Francis, Mark Rickerman, Shannon Landry, David Branch, John Johnston, Rodney Black, Shelia Favor, Daniel Lopez, Wayne Lee, Sean Fanning, Sandy Morton, Brian Avirett and Tobi Fadeyi spoke in opposition to the request, noting increased truck traffic, type and size of buildings, hours of operation, location of buildings, drainage, noise, air quality, median breaks, utilities, lighting, decrease in property values and noise from the train.

Katherine Hogan, John Powell, Lauren Gillard, Hal Morton, Steve Wurst, Samuel Byrd, Frank Massey and Mark Burckhard registered in opposition to the request. A letter of opposition was submitted by the Britton Cemetery Association

# <u>Rebuttal</u>

Mr. Strolle stated that conceptual approval from Oncor has not yet been provided, the Traffic Impact Analysis has not yet been accepted, proposed roadway alignments for Lone Star Road and Heritage Parkway have not been reviewed for compliance and they will have a plan for erosion control on the cemetary property.

Seeing no one else come forward to speak, Chairman Wilshire closed the public hearing.

Chairman Wilshire read a list of outstanding Staff review comments from the Engineering Department.
