Phase 3 is building a visitor center, restrooms and an outdoor amphitheater. Phase 4 is rebuilding log cabins. As of now, the restoration phase is scheduled to be completed in December 2019 or January 2020. A meeting between the Board, Historical Commission and the Architect of the project could be scheduled to be sure both groups are aware of the scope of the project.
