WORK SESSION DISCUSSION ITEMS

Discussion Regarding Potential City Charter Amendments

The Council discussed the amendments to the City Charter. There was Council consensus to amend the following sections: 3.02 Qualifications (to include 9.15 and 12.12 in the same proposition); 3.06.(b) Mayor and Mayor Pro Tem; 3.13.(c) Ordinances in General (option one (1) provided by the City Attorney's office to include adding wording to allow for a separation motion to waive the third (3) reading); 6.01.(b) City Manager (to include adding 6.03 City Secretary and revising 8.05 City Attorney); 10.01 The Planning and Zoning Commission. There was discussion regarding amending the Ethics Ordinance. City Attorney Allen Taylor and Joe Smolinski answered Council questions. Staff was asked to provide the Council with a one page summary of the Charter amendments.

Discussion Regarding Potential Amendments to the Procedural Rules of Council

Allen Taylor made brief comments regarding the Procedural Rules of Council. There was discussion regarding sections 1.05 Order of Business (A and B) and 1.08 Creation of Committees, Boards and Commissions & Election of Mayor Pro Tem. Allen made comments and answered Council questions regarding the creation of sub-committees, who can appoint committees, and Council Members attending Sub-Committee meetings. There was discussion regarding agendas and who is to have final approval of the agenda. There was Council consensus to make changes to the sections 1.05 and 1.08 of the Procedural Rules of Council as well as to incorporate the City Manager Review process.

Director of Parks and Recreation Matt Young discussed the equipment requests for the Parks Department and answered Council questions.
