Consider an Ordinance amending certain sections of Chapter 116 of the Mansfield Code or Ordinances.

Staff recommends passing of the Ordinance.

These proposed amendments to the ordinance referenced would revise specific subsections that relate to permitting donation boxes in the City limits.

This revision would provide additional flexibility on who would be listed and held accountable for compliance with the requirements of Chapter 116 on behalf of the property in addition to the donation box operator.
