Resolution - A Resolution of the City of Mansfield, Texas, Approving an Agreement with the Tarrant County Emergency Services District No. 1 for Fire Protection and Emergency Medical Services; Authorizing the Fire Chief to Execute the Agreement and Act as the City's Representative in all Matters Relating to the Agreement; Finding that the Meeting at Which this Resolution is Passed is Open to the Public as Required by Law; and Declaring an Effective Date

Approval of an Agreement with the Tarrant County Emergency Services District No. 1.

Staff recommends Approval of the Resolution.

Mansfield Fire Department is currently providing mutual aid to Tarrant County ESD No. 1. The current agreement was approved by Council on December 12, 2022 via Resolution Re-3949-22 and was put in place for a 12 month period. This new agreement would be effective retroactively from October 1, 2023 for a term of twelve (12) months. This agreement would continue to renew for additional one (1) year terms until canceled by either party.

This would allow the parties to continue operating under the previously approved Agreement and provide for future renewals. Additionally it would authorize the Fire Chief to serve as the City's representative for the execution and all other matters relating to the Agreement.

Staff has determined that it is in the best interest of the public health, safety and welfare to enter into a Mutual Aid Agreement with the Tarrant County Emergency Services District No. One (District).
