Approval of Resolution

The City of Mansfield Police Department is the grant managing department for the Tri-County Auto Burglary and Theft Prevention Task Force and accepts grant funding from the State of Texas Auto Burglary and Theft Prevention Authority of the Texas Department of Motor Vehicles. Tri-County Auto Burglary and Theft Prevention Task Force will receive income through court awards of seized cash as well as from the sale of assets previously seized and later awarded by a court and that these funds will be commonly referred to as the Tri-County Auto Burglary and Theft Prevention Task Force Asset Forfeiture Account.

The state asset forfeiture program is authorized by Chapter 59 of the Texas Code of Criminal Procedure. This chapter also now requires that the annual budget be submitted to the governing body for adoption. Required by Chapter 59 of the Texas Code of Criminal Procedure.

Funds received from the sale of assets seized and cash seized in certain law enforcement activities in which the task force has participated solely or assisted state law enforcement agencies. Awarded asset funds must be used solely for law enforcement purposes and may not supplant funds previously budgeted. Generally, any funds obtained are used to purchase equipment and supplies and travel/training not funded under the grant. Tracy L.
